Performs role of Therapy Coordinator for the allocated inpatient unit, working collaboratively with the Clinical Nurse Manager, fellow therapy coordinators and the Wellness and Recovery Centre Coordinator, to coordinate group therapy programs.

Delivers consumer centred Social Work services in both group and individual formats to consumers of Bethesda Clinic within a multi-disciplinary, recovery and strengths-oriented framework. This may include both inpatient and day patient group therapies.

Contributes to individual management plans including target social work goals formulated in collaboration with the consumer and where appropriate the family / carer.

Provides professional supervision to junior clinicians and students as required.

Ensures practice is in accordance with the Australian Association of Social Workers Practice Standards 2013 and Code of Ethics 2010 and/or the Society of Professional Social Workers Code of Ethics and Bethesda Health Care policies, procedures and guidelines.

Clinical

- Joint Coordinates the therapy program at Bethesda Clinic Inpatient Service
- involving appropriately skilled and qualified clinicians and contracted clinicians as appropriate.
- Undertakes a range of group, individual, couple, interventions e.g. cognitive behavioural
- therapy, behaviour therapy, psychotherapy, family therapy, systems interventions, and
- counselling.
- Acts as a Senior disciplinary lead for other clinicians to ensure excellence in clinical practice.
- Provides evidence based Social Work services to consumers including screening, assessment, intervention and evaluation
- Actively participates in clinical review meetings and case conferences
- Participates as an active member to ensure collaborative and coordinated multi-disciplinary care
- Actively participates in preparation of the consumer for discharge and the post discharge phase assisting them to develop strategies to navigate the transition. Contributes to discharge summaries and referrals to other services as appropriate
- Provides consultancy to the multi-disciplinary team regarding evidence based best practice in relation to social work functioning to support the delivery of appropriate mental health care
- Supports skill development in colleagues in relation to provision of groups in the clinical setting through co-facilitation
- Contributes to the development of policies and procedures related to area of expertise
- Participates in the development of service agreements as required
- Develops quality improvement initiatives using the quality cycle
- Documents all clinical interventions in the electronic medical record (EMR)
- Ensures clinical handover is delivered according to the requirements of the National Safety Ouality Health Service Standards (NSOHSS) 2nd edition
- Participates in ongoing evaluation of clinical practice
- Performs a public relations function
- Participates in the maintenance of accurate data collection as required by the organisation and private insurance agencies
- Undertakes and initiates ongoing professional development to maintain professional and technical skills at an advanced level
